

Both Yeni Saglik Merger and Turuncu Merger are collectively referred to as the "Internal Reorganisation".


2. DETAILS OF THE INTERNAL REORGANISATION

2.1 The changes in IHH group structure are diagrammatically presented as follows:

- 2.2 Pursuant to the Internal Reorganisation, all the assets and liabilities of Yeni Saglik and Turuncu had been transferred to Acibadem, and Yeni Saglik and Turuncu were subsequently dissolved.
- 2.3 The Internal Reorganisation has no impact on the issued and paid up share capital of Acibadem.

3. RATIONALE FOR THE INTERNAL REORGANISATION

The Internal Reorganisation was undertaken in order to streamline the Acibadem group structure and management.

4. FINANCIAL EFFECTS OF THE INTERNAL REORGANISATION

The Internal Reorganisation will not have any effect on IHH's issued and paid-up share capital and substantial shareholders' shareholdings. There shall be no material effect on the group's earnings and net assets for the financial year ending 31 December 2013.
